

## Transparency in Shkodra Municipality



Implementation of law no. 119/2014, "On the Right to Information",

September 2017



#### 1. Preface.

In April 2016, "Young Intellectuals, Hope" organization published the first Report on Transparency in Shkodra Municipality, which was focused on the enforcement of law nr 119/2014, on "The Right to Information" as well as the development of the process of public consultation focused on the enforcement of law nr 146/2014, on "Public Notification and Consultation".

This Report presents in details the progress ascertained in the growth of transparency level in general in Shkodra Municipality as well as fulfilling those compulsory criteria defined in law no. 119/2015, "For local self-government".

From May 2016 to August 2017, "Young Intellectuals, Hope" organization has proceeded monitoring the level of transparency in Shkodra Municipality, through the surveillance of the official website of Shkodra Municipality well as through requests for information.

During the publication of the first Report in April 2016, resulted that Shkodra Municipality didn't apply correctly around 50% of criteria defined law no. 119/2014 on "The Right to Information". During monitoring of the progress achieved regarding the transparency of Shkodra Municipality, positive progress has been ascertained as the official website of Shkodra Municipality gives information within the standards of law no. 119/2014 on "The Right to Information" making concrete steps in applying the criteria defined by the law and marking a visible progress and positively evaluated by the group of experts who were committed in compiling the report of this progress. The usage of the "Budget Transparency" app, as an innovation, has grown the opportunity of citizens, community, the private sector of civic society and other actors to monitor the budget implementation by Shkodra Municipality.

The findings and the recommendations of this report encourage local directors regarding the achieved progress of transparency as well as the constant improvement of the quality of transparency, offering information for the citizens in an easy and understandable way, affecting the civic involvement in local governance as well as in the improvement of the governing quality and services offered locally.

This report was prepared with the initiation of "Young Intellectuals, Hope" organization, in the framework of the project "Be active, build the future", financially supported by Olof Palme International Centre in Albania through the financing of Swedish Government. #### 2. Methodology

The composition for this report was made possible through official communication with Shkodra Municipality, direct contacts with local leaders and administrators, monitoring the official website of Shkodra Municipality <a href="www.bashkiashkoder.gov.al/">www.bashkiashkoder.gov.al/</a>.

During May 2016-August 2017, 20 requests for information have been sent and the answer in each case was given within the legal term.

The collected information was confronted with the legal provisions, facilitating the making of conclusions and recommendations for the improvement of work, regarding the implementation of law and the increase of transparency. The report is mainly focused on following law no. 119/2014, on "The Right to Information" and law nr 139/2015, for "The Local Self-governance".


The results of the monitoring were compared to the results of the first Report on the "Transparency of Shkodra Municipality", published in April 2016, measuring the progress achieved regarding the transparency increase of Shkodra Municipality.

#### 3. Transparency progress in accordance with the law of The Right to Information.

Point 1 of article 7 of law no. 119/2014, on "The Right to Information", defines that: "the public authorities shall make available for the public, in their official website the following information categories: a) a description of the organizational structure, functions and duties of public authority". In this point, results to have been made a progress compared to the first Report on Transparency of Shkodra Municipality, published in April 2016 from "Young Intellectuals," Hope" organization.


From monitoring the official online website, results to have been published the verdict no.55 on 20/03/2017 of Shkodra Municipality for "The Approval of the administration and institutions structure depending on Shkodra Municipality, for 2017".

In accordance with the definitions of letter c, point 1, article 7 of law no. 119/2014, on "The Right to Information", where should be given information about the procedures that should be followed to make a request for information, the postal and electronic address for depositing of requests for information, as well as the procedures of appealing the respective decision, from the Report on "Transparency in Shkodra Municipality" of April 2016, this information is not found, while currently results that the "request form" and "appeal form", may easily downloaded by everyone, marking a positive progress.

In accordance with the definitions of letter  $\varsigma$ . 1<sup>st</sup> point of 7<sup>th</sup> article of law no. 119/2014, on " **The Right to Information**", where should be given information about the location of public authority offices, working hours, name and contact of the coordinator for The Right to Information, from monitoring results that such an information is fully featured according to the law.

In accordance with the definitions of letter d, point 1, article 7 of law no. 119/2014, on "The Right to Information", where should be given information about the education, qualifications and functionaries salaries, who are obligated to declare their wealth, in accordance with the law, the structures of the salaries of other employees, as well as a description of the selection procedures, the competences and duties of high functionaries of the public authority and the procedures they follow to make decision, from the Report on "Transparency in Shkodra Municipality", published in April of 2016, resulted that such an information could not be found even for the Mayor.

According to the monitoring, there <u>is a partly positive progress ascertained</u>, where data regarding the education, selection procedures, competences and duties of high functionaries of Shkodra Municipality, is still missing.

On the other side, there are currently published in the "Transparency Program", the salaries of the functionaries, who are obligated to declare their wealth, as well as the structures of the salaries of the other employees are presented in the verdict no. 55, 20/03/2017 of Shkodra Municipality on "The approval of the administration and institutions structure, depending on Shkodra Municipality for the year 2017".

Picture 6. Official website of Shkodra Municipality, "Mayor of Shkodra Municipality"




With regard to the procedure that these officials follow in order to make decisions, there are only a few decisions about power delegation for vice mayors, but since these acts are temporary and with delegating functions it cannot be clearly understood what are their permanent functions!

Regarding the terms of the letter dh. and point 1 of Article 7 of Law No.119 / 2014, "On the Right of Information", where should be given information on the monitoring and control mechanisms operating on public authority, including strategic working plans, audit reports from the Supreme Government Audit or other entities, as well as the documents that contain performance indicators of the authority, results that audit reports have been published, which constitute a positive progress with respect to the previous report!

Also in terms of existing strategic plans, they are not updated as well as there are missing documents containing performance indicators of public authority!

Picture 7. Official website of Shkodra Municipality, "Strategic Plans"




With regard to the letter e. of point 1 of article 7 of the law, where should be given information about the budget and expenditure plan for the following financial year, as well as any annual budget implementation reports. In those cases where the public authority is self-financed by the license fees or any other form of direct financing by the entities regulated by it, the documents showing the state of settlement of the obligations by the licensed entities, in connection with this point, the information if fully provided for the previous years, as well as for the budget of 2017, where the budget plan 2018-2019 is also published.

With regard to the letter ë, point 1, Article 7 of law no. 119/2014, on "The Right to Information", where should be given information on the procurement procedures or competitive procedures of concession/public and private partnership, respectively, according to the prediction of law no. 9643, 20/12/2006, on "Public Procurement" and law no. 125/2013, on "Concessions and public private partnership", carried out on behalf of public authority, including:

- i. List of signed contracts
- ii. Contracted amount
- iii. Contract parties and description of contracted goods and services
- iv. Information for contracts implementation and monitoring
- v. As well as guidelines and policies

<u>From the monitoring, it results that there is a positive progress</u> in providing information on procurement procedures, contracted amounts, contracted parties and description of contracted services and goods.


As above, in the official website of Shkodra Municipality, was published paper no. 2495 Shkodra Municipality Prot, 20/02/2017, Subject on "Approval of register of predictions of public procurement in Shkodra Municipality, year 2017", the Public Procurement Register was published. Also in the official website of Shkodra Municipality, "Budget Transparency", information on budget is given through an app, which is easily accessible from every citizen, where information on budgeting in available.



With regard to the definitions of letter gj., point 1, article 7 of the law, where should be provided information on each mechanism or procedure, through which interested people may present their thoughts or affect in any way the drafting of laws, public politics or the exercising of the functions of public authority. From monitoring, results that Shkodra Municipality in her official website has started a new section on "Public Consultation", where interested people can express their thoughts about public politics or the exercise of public authority. #### 4. Conclusions and recommendations

From monitoring the liabilities derived from the legislation in power, regarding The Right to Information and transparency of local institutions, results that in Shkodra Municipality, positive progress is made, reflected in continuity for the purpose of their observance, which shows commitment and responsibility of these local officials. Regardless the improvement in this direction, it should be emphasized that there is still progress to be made in respecting the obligations imposed on local authorities to guarantee The Right to Information.

This progress report highlights the visible progress in the direction of transparency increase in Shkodra Municipality as mentioned in details above. In order to have a continuity in keeping and increasing the level of transparency, it is recommended as follows:

- The good practices and the positive progress of Shkodra Municipality in the increase of the transparency of its activity, must be passed on to the administrative units, especially to the public societies, that depend on Shkodra Municipality.
- As not everyone is familiarized in using the official website and accessing the information it contains, or do not know how to use it; citizens prefer to directly turn to the offices of local institutions, as they encounter difficulties and bureaucratic hurdles in drafting requests for information or it is easier for them to directly get information, thus is important adding service desks in administrative units of Shkodra Municipality.
- The mechanism and procedures in making requests and appeals, regarding the actions or inaction of public authority, as well as every mechanism or procedure, through which interested citizens may present their opinions or affect in any other way the drafting of laws, public politics or the exercising of the functions of public authority, should be clearer for citizens and groups of interest.
- Continuous informing citizens on legal provisions that guarantee them getting information and the procedures that must be followed in order to execute this right, shall be attained as well as through public meetings in the whole territory of Shkodra Municipality.

- Continuous informing administration employees and monitoring their behaviour, with regard to following the procedures and respecting the legal terms for giving information.
- Encouraging professionalism to improve the quality and form of informing citizens through strengthening the administration's capacity to best fulfill the obligations imposed by the law on the right to information;
- Continuous update of the official website, regarding the information given and the program of transparency from the Municipality, as part of the legal obligation.
- Strengthening cooperation with civil society and joint projects or activities, promoting transparency monitoring mechanisms
- Various forms of online civic participation should be created, through online blogs/discussions or mobile apps.

Shoqata "Intelektualët e rinj, Shpresë" e cila që nga muaji Maj 2016 është angazhuar plotësisht në monitorimin e progresit të nivelit të transparencës në Bashkinë e Shkodrës, ka publikuar sot Progres Raportin mbi Transparencën në Bashkinë Shkodër në zbatim të ligjit Nr. 119/2014, "Për të drejtën e informimit" në kuadër të projektit "Bëhu aktiv, ndërto të ardhmen!" me mbështetjen financiare të Olof Palme International Center në Shqipëri përmes financimit të Qeverisë Suedeze.

Progres Raporti mbi Transparencën në Bashkinë Shkodër evidenton hapat pozitiv të arritura nga Bashkia Shkodër në drejtim të rritjes së nivelit të transparencës në veprimtarinë e saj. Raporti i parë mbi Transparencën në Bashkinë Shkodër i publikuar nga shoqata "Intelektualët e rinj, Shpresë" në Prill të vitit 2016, konstatoi se Bashkia Shkodër zbatonte jo në mënyrën e duhur rreth 50% të kritereve të përcaktuara në ligjin Nr. 119/2014, "Për të drejtën e informimit".

Sipas progres raportit të publikuar rezulton se Bashkia Shkodër ka një progres të dukshëm në përmbushjen e të gjitha kritereve të përgjithshme për garantimin e të drejtës për informim të përcaktuara në ligjin Nr. 119/2014, "**Për të drejtën e informimit**" duke krijuar kushtet e nevojshme për transparencë dhe informimin e qytetarëve në Bashkinë Shkodër.

Raporti ndër të tjera rekomandon se praktikat e mira dhe progresi pozitiv i Bashkisë Shkodër në rritjen e transparencës së veprimtarisë së saj duhet që të shtrihet edhe tek njësitë administrative dhe sidomos tek shoqëritë publike të cilat janë nën varësin e Bashkisë Shkodër.
